## UCAS applications for September 2026 entry



The application deadline for **2026 entry** to undergraduate courses is **18:00 (UK time) on 14 January 2026**. This is the **equal consideration deadline**, meaning universities must consider all applications received by this time equally.

**If you want to make the equal consideration deadline, you would need to complete an independent application at this stage.**

If you miss the January UCAS deadline, you can still apply; however, your application will no longer be guaranteed equal consideration. This means some courses may already be full or closed. That said, there are still plenty of options available, particularly if you are flexible about your choice of university or course.

### **If you apply through [DistanceLearningCentre.com](https://DistanceLearningCentre.com):**

- Your tutor will check your personal statement and form for content, spelling and grammatical errors and advise accordingly
- Your tutor will also provide a reference.

**Predicted Grades** - if you have achieved 24 credits or more (subject to moderation), your tutor will be able to predict the rest of the diploma grades as they will have marked enough of your work to make an informed prediction.



If you have achieved less than 24 credits your tutor will put in grades that have been recommended so far. These grades are NOT predicted grades for the whole course; they are recommended grades for the units you have completed (subject to moderation). Before they offer places, universities can, and do, get back to us later in the course to see how you are doing, and whether you are likely to meet their entry requirements.

**If you apply as an independent student:**

- You can apply at any time and do not need to adhere to our deadlines.
- Your form will not be checked.
- You will not receive a reference from your DistanceLearningCentre.com tutors.

## March Moderation 2026

If you are aiming to finish your Diploma in time for March 2026 moderation, you will need to have completed **45 credits** by **Friday 16th January**. The deadline for submitting your final unit assessment is **Friday 27th February**.

Remember to update your Individual Learning Plan (ILP) and keep in touch with your tutor to update them on your progress as you work towards this deadline.
